Reporting of the Annual General Meeting will be held on 26<sup>th</sup> September 2022 (Monday) at 5-30 P.M. at our Co-operative Society Office, Nirmal Mitra Bhawan, Kolkata-700 087.

Merit Award to self or sons/daughters/spouse of the Member / Staff will also be distributed on that occasion. Member / Staff are requested to submit their applications immediately along with a photocopy of the mark sheet for getting Merit Award of their children/spouse or self who have passed Madhyamik/Higher Secondary or equivalent examinations with 60% and above marks in aggregate and also to those who have completed Graduation level of any stream on or after 1<sup>st</sup> April, 2022 by fulfilling the following criteria:

- The Universities/Institutions must be recognised by the Government (State or Central) or U.G.C.
- The Technical or Management Institutions must be recognised by AICTE.
- Only Honours Graduate students of general streams e.g. Science, Commerce and Arts securing 60% marks are eligible.
- In case of Technical and Management streams (e.g. B. Tech, B.B.A., B.C.A.), the students who will secure 7.5 C.G.P. (i.e. Cumulative Grade Point) are eligible.
- The students who received MBBS/BDS degree from M.C.I. recognised Institutions are also eligible.
- Diploma holder students as well as the students under any Open University are not eligible for this scheme.

The copy of the mark sheet is to be verified duly by Directors/Delegates/Representatives of the Society or the Branch Manager of the respective branch where there is no such Director/Delegate/Representative of the Society.

All the Members are requested to attend the programme to make it grand success.
